ENTRY FORM & CONDITIONS OF ENTRY

- 1 The event will be run under the Racing Rules of Sailing with RYA prescriptions and Class Association rules, except as stated in the sailing instructions.
- 2 All entrants must sign a declaration that they have valid third party insurance for a minimum of £3,000,000 and a valid class certificate.
- 3 All boats must have adequate buoyancy and personal buoyancy must be of an approved design and worn at all times when afloat, amending RRS 40.
- 4 The safety of a boat and her entire management shall be the sole responsibility of the owner/competitor racing the boat, who must ensure that the boat and crew are adequate to face the conditions that may arise during the course of the race. Neither the sailing instructions nor the inspection of the boat under these conditions in any way limits or reduces the absolute responsibility of the owner/competitor for the crew, the boat and the management thereof. The race organisers shall not be responsible for any loss, damage, death or personal injury, howsoever caused, to the owner/competitor, the skipper or crew, as a result of their taking part in the race or races. Moreover every owner/competitor is absolutely responsible for the suitability of the boat for the race or races.
- 5 All participants are Guests of West Kirby Sailing Club for the duration of the event, and will be required to sign the Visitors Book and be bound by Club rules. Attention is drawn to rule 47 (liability of the Club), a copy of which is on display on the club notice board.

Parent/Guardian Declaration

Under law, the above named competitor is my dependent. I accept the Disclaimer of Liability below, which excludes my dependent's right to claim compensation in certain circumstances. I declare that, where the boat is not supplied by the event organisers, during the event the boat sailed by my dependent will have a valid and current third party insurance of at least £3m or the equivalent in another currency. I confirm that my dependent is competent to take part. I consent to my dependent receiving emergency medical treatment. I consent to the taking of pictures and video during the event and waive any rights to payment for such images. I confirm that the competitor is medically fit to take part in the event and any supporting activities on the above dates and I have listed overleaf any medical conditions that the organisers need to be aware of.

During the event (tick one box only):

I will be responsible for my dependent throughout the event, and during the time my dependent is afloat I will be available at the event venue.

I appoint the person named below, who has agreed to act in loco parentis. He/she will be responsible for my dependent throughout the event. During the time my dependent is afloat he/she will be available at the event venue.

Disclaimer of Liability

Competitors or their parent/guardian - if below 18 years of age on the day of the event, are entirely responsible for their own safety, whether afloat or ashore, and nothing reduces this responsibility. It is for them to decide whether their boat is fit to sail in the conditions in which it will find itself. By launching or going to sea, competitors or their parent/guardian confirm the boat is fit for those conditions and they are competent to sail and compete in them. Nothing done by the organisers can reduce the responsibility of the competitors or parents/guardians, nor will it make the organizers or their contractors responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the competitor taking part in the racing. The provision of patrol boats does not relieve competitors and their parents/guardians of their responsibilities. For the sake of clarity "the organisers" encompass everyone helping to run the event.
